Until the Meeting has been completed, you agree you will not initiate or pursue any litigation, arbitration or other means of mediation.

In the event we cannot reach a resolution in the Meeting, then the dispute will be resolved exclusively in the courts of the State of Wisconsin (in any county chosen by Comstar) or, should the dispute satisfy the requirements for federal jurisdiction, the United States District Court for the Eastern District of Wisconsin. You consent to in personam jurisdiction by any of those courts. This agreement shall be governed by, and the terms of this agreement shall be construed and interpreted in accordance with, the laws of the State of Wisconsin, without reference to conflict of laws principles.

If any party breaches any of the terms of this agreement, and the amount in controversy (exclusive of attorneys fees and costs) is less than or equal to \$5000, then the non-breaching party shall be entitled to recover from the breaching party the reasonable, actual costs, expenses and attorney's fees incurred by the nonbreaching party in connection with enforcement of this agreement.
